- Minimum five (5) years of experience in environmental and social assessment studies financed by the World Bank and / or other International Financial Institutions (IFIs) such as IFC/EBRD/EU/AFD and United Nations,
- Experience in at least two (2) projects in preparation of Environmental and Social Documents (ESIA Report, SEP and etc.) in WWTP projects in size and complexity for IFI funded projects,
- Experience in at least two (2) projects in preparation of RP/Ex-Post Social Audits for IFI funded projects and knowledge of national regulations pertaining to land acquisition and resettlement.

Key Experts will not be evaluated at this stage.

The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank's "Procurement Regulations for IPF Borrowers" November 2020, setting forth the World Bank's policy on conflict of interest.

Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture and/or a subconsultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.

A Consultant will be selected in accordance with the Consultant's Qualification-based Selection (CQS) method described in the Procurement Regulations and to be specifically set out in the Request for Proposals.
